Dear Friends,

I am excited to share with you how the Foundation provided support to WSCC students in 2015, which celebrates the generosity of a collective force of donor gifts along with corporate gifts and grants, helping our students to earn a college credential.

Five new scholarship opportunities for students were added this year.

The Eighth Tina K. Schaad Memorial Scholarship Cake Auction was held in April to benefit the Student Emergency Fund, Textbook Fund, and Senior Educational Fund.

Twenty-five cakes were entered along with non-baked goods donated for the silent auction.

Students may experience unexpected financial difficulties while completing their degree. This year alone, the Foundation has provided over \$7,000 in emergency funds to the students.

In September, the annual Foundation Scholarship and Donor Reception was held where 30 students were awarded nearly \$50,000 to help defray the cost of their education. This is a very special event where students get to meet the donors face-to-face and show their appreciation for the donor gifts and the donors can congratulate the students on their hard work. Three of our newer scholarship sponsors increased their support in the past year. Kim and Ray Blackburn (pictured inside the front cover) added substantial funding to the

Wendy's Adoption Scholarship during the second of a three year fundraising promotion; the O'Briens added to the Tim and Jane O'Brien Nursing Scholarship; and Mr. Henry Goehring (right) was so pleased with the impact his scholarship had in the first year that this year he increased the number of scholarships established in memory of his wife so that more students could benefit.

The WSCC Foundation Alumni & Friends Association held local fundraisers in support of a new scholarship in the Association's name. See more about it on page 13. Gifts to the Annual Fund remain consistent from year to year, but the Foundation has plans to expand the reach of the campaign in response to increasing needs of local students.

The board is working side by side with College leadership to increase gifts made by administratiors, faculty, and staff through payroll deduction. The board is also working on a scholarship that helps veterans transition to professional careers.

To help spread the word of scholarhip opportunities in the community, a four-page folder the summarizes Foundation scholarships and provides information about applying for them is distributed to school guidance counselors, WSCC faculty members, and at community presentations.

Since gifts in support of the Evergreen Arts and Humanities Series (EA&HS) are made to the Foundation for distribution to the program, the Foundation provided additional marketing assistance to the EA&HS committee in the past year, primarily in support of the largest and perhaps most significant event in EA&HS history, the overwhelmingly successful presentation of The Vienna Boys Choir.

OPTIONS FOR CHARITABLE GIFTS

GIVING OPTIONS — GIVING OPPORTUNITIES

Gifts to Washington State Community College Foundation, regardless of size, benefit our students, the college, and ultimately the communities in which our students live and work. Every gift is significant because every gift helps to promote quality education, a skilled workforce, and a future of growth and success in southeastern Ohio.

Collectively, donor gifts help to sustain the present and secure the future for the college and for all those who want to improve their lives and the lives of their families.

Outright gifts often include gifts of cash, securities, or property for which the donor receives tax advantages. For example, in the case of gifts of appreciated securities, the donor is entitled to a charitable income tax deduction based upon the fair market value of the securities, and capital gains taxes are avoided.

Deferred gifts involve the irrevocable transfer of an asset to a charitable organization. The donor may retain either an income stream or the remainder interest. Current tax laws permit several planning alternatives for deferred gifts allowing the donor to receive a charitable income, gift, or estate tax deduction. These planned giving options include Charitable Remainder Trusts, Charitable Lead Trusts, Life Insurance, and others.

Bequests are gifts made to a charity as a named beneficiary in the donor's will or trust, and may provide for an outright or a split-interest gift. The donor's estate may receive an estate tax deduction for the value of the gift.

Employer Matching Gift Programs: Many employers have matching gift programs that match their employees' gifts of cash or appreciated securities, adding additional support in the name of the donor. When a donor gives a gift to a charity, he or she notifies the Human Resources department of the gift and completes the employer's matching gift form.

Donors are encouraged to discuss their planned gift and major gift plans for a charity with their attorney or financial planner.

What donor gifts accomplish:

- Defray the cost of education for those who need financial assistance to build a future for themselves and their families.
- Provide new facilities & educational equipment through institutional capital improvement.
- Provide leadership training and educational travel opportunities for students and faculty alike.
- Secure the college's future through deferred gifts.
- Support campus arts and cultural events provided to the community without charge.
- Kept at-risk students in college.


PLEASE JOIN US!
