**A review by the U.S. Department of Education, Department of Homeland Security (DHS) and Social Security Administration indicates that you must confirm your U.S. citizenship or eligible non-citizen status to qualify for Federal Financial Aid.**

**INSTRUCTIONS** - Present the original proof of citizenship document in person at WSCC's Office of Financial Aid where a photocopy will be made. If you are unable to appear in person at WSCC, you must present the documentation in the presence of a Notary Public. The Notary will verify the original citizenship documentation you provide and complete the Notary's Certificate of Acknowledgement at bottom. Return original notarized Citizenship Form with a copy of proof of citizenship (used with Notary) to the Office of Financial Aid.

Below is a list of acceptable documentation, which you may submit to confirm your U.S. citizenship or eligible non-citizen status. In addition, some documents are valid through a certain date. If you submit a document, which has an expiration date, additional documentation may be requested and in subsequent years.
